PAYMENT IN FULL IS DUE BY APRIL 16, 2009.

SITE FEE PROVIDES CAMPING FROM MAY 1, 2009 TO COLUMBUS DAY AND ON SITE STORAGE FROM COLUMBUS DAY TO APRIL 30, 2010.

SITES CAN NOT BE OCCUPIED AND UTILITIES WILL BE TURNED OFF UNTIL PAYMENT IS MADE IN FULL AND ALL ACCUMULATED FEES ARE SATISFIED. CAMPERS NOT PAID IN FULL BY DUE DATE WILL BE CHARGED \$2.00 PER DAY STORAGE FROM MAY 1, 2009.

THERE WILL BE NO OFF SITE STORAGE AVAILABLE IN THE CAMPGROUND. RV'S LEFT ON PARK PROPERTY FOR 96 HOURS WITHOUT PAYMENT IS CLASSIFIED ABANDONED AND IS SUBJECT TO DUE PROCESS ACCORDING TO THE LAW.

****ONLY THE CAMPERS LISTED ON THIS CONTRACT ARE PERMITTED FREE ENTRY TO POOL FACILITIES. VISITORS WILL PAY THE DAILY POOL RATE.**
